

BOARD MEETING BREAKDOWN DAVID HILYER, CEO

The Local Government Health Insurance Board met on August 13, 2024 to vote on benefit enhancements and set premiums for calendar year 2025. The board approved a 4.75% premium increase for active employees, non-Medicare retirees, and Medicare retirees. 2025 marks the 32nd year the Plan has been in existence. The average rate increase over that time period has been 4.23%, compared to the national average of 7.85%*.

We have spoken to several non-LGHIB member units around the state who are experiencing a double-digit rate increase for 2025. The management tools and programs implemented by Local Gov Health and Wellness are helping to create an affordable, predictable, best-in-class health insurance program that is improving the health and well-being of our members!


A focus for 2025 is continuing to add value to our Plan. Several enhancements were approved by the Board such as a voluntary cancer policy offered through Southland Benefit Solutions and a YMCA benefit. Our team is currently working on even more enhancements to be added soon!

OPEN ENROLLMENT IS RIGHT AROUND THE CORNER

Open enrollment is coming in the month of November! If your unit or your members need to make changes, Open Enrollment is the time to submit them to Local Gov.

As a reminder, below are changes that can be made during open enrollment.

During open enrollment, eligible members can:

- Enroll in health and voluntary coverages
- Cancel health* and voluntary coverages
- Add dependent and/or family coverage
- Drop dependent and/or family coverage

*Must provide proof of other coverage

During open enrollment, units can:

- Change their effective date of insurance for new hires
- Add or drop retiree coverage
- Add or drop coverage for elected officials
- Add or drop BCBS dental coverage

DON'T DELAY YOUR DMR

Starting January 1, 2025, Prime Therapeutics will take over as the pharmacy benefit manager for Local Gov Health + Wellness. Any prescriptions filled prior to January 1, 2025 will be processed by OptumRx; after January 1, 2025, prescriptions filled at the pharmacy will be processed by Prime Therapeutics.

During this transition, members will have a limited window to file their direct member reimbursement (DMR) claims for tier 2 and tier 3 prescription drugs with OptumRx. Any DMR claims prior to January 1, 2025 must be submitted to OptumRx. The fastest way to receive reimbursement is through the OptumRx website. For detailed instructions on filing a DMR with OptumRx, click here.

All qualifying reimbursement requests must be submitted through OptumRx.com by December 31, 2024, as the online portal will close on January 1, 2025. If claims are not submitted online by this deadline, members will need to complete a paper form and mail it to Optum with the necessary receipts. All claims filled by a pharmacy after January 1, 2025 will need to be submitted to Prime Therapeutics. More information about the reimbursement process with Prime will be provided in the near future.

BE OUICK ABOUT OLES

Qualifying life events (or a QLE) are special circumstances in which eligible employees and dependents are able to enroll in coverage upon the loss of other coverage, and participants may add new dependents due to certain qualifying events (marriage, birth, etc.).

The participant must request enrollment and provide proof of the qualifying event within 60 days of the event.

It is vital that Local Gov receive all necessary supporting documents when requesting a special enrollment. This may include, but is not limited to:

- Birth certificate
- Marriage certificate
- Proof of loss of other coverage

IMPORTANT COBRA PAYMENT CHANGES

Local Gov is no longer accepting credit or debit card payments for COBRA coverage premiums over the phone. Instead, these payments can only be made through the subscriber's my.lghip.org account.

Subscribers can still make e-check payments through their my.lghip.org account or by contacting our office at 334-851-6802. To make an e-check, credit, or debit card payment, subscribers must login to their my.LGHIP account, select "View/Pay Premium" on the side navigation bar, and follow the instructions.

Additionally, COBRA payments can be processed via automatic bank drafts, which are scheduled for the first business day of the month. Subscribers are sent auto draft forms in the mail for auto bank draft. If you're interested, please complete the enclosed auto draft form and return it along with a voided check to P.O. Box 304901, Montgomery, AL 36130.

DON'T BE LATE TO GET THE BEST RATE

Automatic bank draft is the easiest way to ensure your payment is never late! Auto draft is a service offered at no charge to you. Check your monthly invoice for the total amount to be withdrawn from your unit's bank account on or after the first day of the following month.

As a qualification for the preferred rate, your unit can not have been delinquent on two premium payments within the last two years. Auto draft prevents late payments and helps you keep your unit's premiums low!

How to Sign Up For Auto Draft:

Please include a voided check with your <u>Pre-</u> <u>Authorized Payment Service Authorization</u> <u>Agreement form</u> to verify account information for

withdrawals from your checking account or a deposit slip for withdrawals from a savings account.
